Letter of Intent from Applicant Artist Eduving Porras to Continue His Artistic Career as a Lawful Permanent Resident of the United States of America

Being a member of the ARSNY Artists Rights Society endorses the quality and recognition of my work nationally and internationally. I have been interviewed by prestigious media in America and Europe, highlighting my career and my contributions to art. My participation in the Shein X platform has resulted in significant commercial success, with illustrations on fashion garments that have been published and sold out. As a Creator Panelist on Instagram, I have evaluated emerging artists and come up with ideas to improve the platform's public tools for creators.

Currently, I am involved in artistic events in Valencia, Spain, and I continue to collaborate with Shein X through a formal contract after my successful participation in the project convened by Warner Bros. through Shein Group. I work as a Creative Graphic Designer at Technopack Corp and am developing my business line Eduvismo Art, which reflects my signature style full of color and joy.

Obtaining Lawful Permanent Residency in the United States would represent an invaluable opportunity for me, as it would allow me to continue expanding my artistic career in a country that values and encourages creativity.
